Morgan Adams is the founding partner of the Law Offices of Morgan Adams. He is Board Certified in Civil Trial Advocacy by the National Board of Trial Advocacy and is a member of the Multi-Million Dollar Advocates Association, having secured many million and multimillion dollar recoveries for clients. In 2012 he received the largest punitive damages verdict against a drunk driver in the history of Tennessee, with a total verdict of \$9.25 Million Dollars. That year he also became the first lawyer in the history of the American Association for Justice's Trucking Litigation Group to receive its Lifetime Achievement Award. He retired after 22.5 years from the United States Marine Corps (Reserve) in 2006. He is a Leaders Forum member of the American Association for Justice.
